The Water Supplies Department (WSD) stipulates that all every pipe or fitting shall be of the British Standard in accordance with the Waterworks Regulations. The authority accepts certification or test reports from laboratories accredited by HOKLAS under the following sub-categories :

	◆ Pipes

We provide testing services for the confirmation of compliance with the relevant British Standard as required by the Water Supplies Department (WSD).
